Competent authorities of foreign governments in the field of transport

The Ministry for Communities, Territories and Infrastructure Development of Ukraine is the central authority within the system of central executive authorities responsible for forming and implementing state policy in the field of road transport and has the honour to address with the following.

In order to further optimise the border crossing process, we continue to scale the "Electronic Border Crossing Queue" system. Thus, starting from 12 February 2024, it is planned to introduce the need to register in the system for all buses transporting passengers through border crossing points with countries neighbouring Ukraine. To do this, a carrier engaged in international road passenger transportation must register the relevant flight in advance before crossing the Ukrainian border. We would like to draw your attention to the fact that this requirement will apply to all road carriers that will carry out regular or irregular passenger transportation through any checkpoint.

Taking this opportunity, the Ministry for Communities, Territories and Infrastructure Development of Ukraine once again assures in its highest respect the foreign partners and expresses hope for further fruitful cooperation in the field of transport.
