Vlada RS je sprejela Odlok o začasni prepovedi izvajanja tehničnih pregledov in drugih postopkov v zvezi z registracijo motornih vozil ter dela v tahografskih delavnicih v Republiki Sloveniji, s čimer se je do 16. 4. 2020 začasno prepovedalo izvajanje tehničnih pregledov in drugih postopkov v zvezi z registracijo motornih vozil ter delo v tahografskih delavnicih v Republiki Sloveniji. **Veljavnost prometnih dovoljenj vključno z zavarovanjem motornih vozil ter ADR certifikatov za prevoz nevarnega blaga se bo zato podaljšala do 16. 5. 2020.**

Vlada RS je tudi sprejela Odlok o začasni prepovedi ponujanja in prodajanja blaga in storitev neposredno potrošnikom šolam varne vožnje in pooblaščenim organizacijam s področja voznikov in vozil v Republiki Sloveniji, zato **se veljavnost vozniških dovoljenj podaljša do 16. 5. 2020.**

CIRCULAR NOTE

The Ministry of Foreign Affairs of the Republic of Slovenia presents its compliments to the diplomatic missions, international organisations and missions of international organisations in the Republic of Slovenia, and has the honour to communicate the following:

The Government of the Republic of Slovenia has adopted an ordinance on the temporary suspension of vehicle roadworthiness testing and other procedures related to vehicle registration as well as operations of tachograph fitting workshops in the Republic of Slovenia. The **validity of vehicle registration certificates, motor vehicle insurance policies and ADR certificates** for transport of dangerous goods has therefore been **extended until 16 May 2020**.

The Government of the Republic of Slovenia has also adopted an ordinance on a temporary ban on the sale of goods and services directly to consumers – safe driving schools and authorised drivers and vehicle organisations in the Republic of Slovenia. As a consequence, the **validity of driving licences has been extended until 16 May 2020**.

The Ministry of Foreign Affairs of the Republic of Slovenia has the honour to request that the information on the extension of validity of driving licences and registration certificates issued in the Republic of Slovenia be forwarded to competent authorities in your country.

The Ministry of Foreign Affairs of the Republic of Slovenia avails itself of this opportunity to renew to the diplomatic missions, international organisations and missions of international organisations in the Republic of Slovenia the assurances of its highest consideration.
