

## Multilateral Agreement M324

under section 1.5.1 of ADR

concerning driver training certificates in accordance with 8.2.2.8.2 of ADR

and safety adviser certificates in accordance with 1.8.3.7 of ADR

- (1) By derogation from the provisions of the first paragraph of 8.2.2.8.2 of ADR all driver training certificates the validity of which ends between 1 March 2020 and 1 November 2020 remain valid until 30 November 2020. These certificates shall be renewed for five years if the driver furnishes proof of participation in refresher training in accordance with 8.2.2.5 of ADR and has passed an examination in accordance with 8.2.2.7 of ADR before 1 December 2020. The new period of validity shall begin with the original date of expiry of the document to be renewed.
- (2) By derogation from the provisions of 1.8.3.16.1 of ADR all certificates of training as safety adviser for the transport of dangerous goods the validity of which ends between 1 March 2020 and 1 November 2020 remain valid until 30 November 2020. The validity of these certificates shall be extended from the date of their original date of expiry for five years if their holders have passed an examination in accordance with 1.8.3.16.2 of ADR before 1 December 2020.
- (3) This agreement shall be valid until 1 December 2020 for carriage on the territories of the ADR Contracting Parties signatory to this Agreement. If it is revoked before that date by one of the signatories, it shall remain valid until the above-mentioned date only for carriage on the territories of those ADR Contracting Parties signatory to this Agreement which have not revoked it.

## **Večstranski sporazum M324**

po razdelku 1.5.1 ADR

v zvezi s certifikati o usposobljenosti voznika v skladu z 8.2.2.8.2 ADR

in potrdili o usposobljenosti varnostnega svetovalca v skladu z 1.8.3.7 ADR

- (1) Z odstopanjem od določb prvega odstavka 8.2.2.8.2 ADR vsi certifikati o usposobljenosti voznika, katerih veljavnost poteče med 1. marcem 2020 in 1. novembrom 2020, ostanejo veljavni do 30. novembra 2020. Veljavnost certifikatov se podaljšajo za pet let, če se voznik udeležbi obnovitvenega usposabljanja v skladu z 8.2.2.5 ADR in opravi preizkus znanja v skladu z 8.2.2.7 ADR do 1. decembra 2020. Novo obdobje veljavnosti se začne s prvotnim datumom prenehanje veljavnosti dokumenta, ki ga je treba obnoviti.
- (2) Z odstopanjem od določb 1.8.3.16.1 ADR vsa potrdila o usposobljenosti varnostnega svetovalca za prevoz nevarnega blaga, katerih veljavnost poteče med 1. marcem 2020 in 1. novembrom 2020, ostanejo veljavna do 30. novembra 2020. Veljavnost teh potrdil se podaljša za pet let od datuma prvotnega poteka veljavnosti, če imetniki opravijo preizkus znanja v skladu z 1.8.3.16.2 ADR do 1. decembra 2020.
- (3) Ta sporazum velja do 1. decembra 2020 za prevoz na ozemlju pogodbenic ADR, ki so ga podpisale. Če ga je en podpisnik preklical pred tem datumom, ostane veljaven do navedenega datuma samo za prevoz na ozemlju tistih pogodbenic ADR, ki so ta sporazum podpisale in ga niso preklicale.
