Administrative demeanors in road traffic

149.4. Violations of general road traffic rules

For not having documents necessary for transport of oversized or overweight cargo: warning or fine to the driver 2 LVL.

For violation regulations concerning driving and rest periods of drivers, or recording equipment:

- fine to the driver 50 100 LVL;
- fine to the legal entity 400 500 LVL

For ordering to use a vehicle in the breach of regulations concerning driving and rest periods of drivers, or recording equipment:

- fine to the person responsible for the use of the vehicle 100 150 LVL;
- fine to the legal entity 700 1000 LVL.

149.32. Infringements of regulations on road transport of passengers

For transport of more passengers than stated by the manufacturer: warning or fine to the driver 10 LVL.

For transport of children in the bus without presence of attendant: warning or fine to the driver 10 LVL.

For violating regulations concerning transport of passengers in lorry outside the cabin: fine to the driver 20 LVL.

For transport of passengers outside the cabin of tractors, in a trailer (semi-trailer) and in load compartment of motorcycle: fine to the driver 20 LVL.

149.33. Infringements of regulations on road transport of goods

Exceeding mass or axle-load stated by the manufacturer over 5% - warning or fine 10 LVL to the driver.

Exceeding mass or axle-load stated by the manufacturer over 20% - fine 30 LVL to the driver.

Infringement of regulations concerning placement and fastening of cargo - fine 20 LVL to the driver.

Transport of containers or timber products in vehicles not intended for this purpose and not registered accordingly - fine 40 LVL to the driver.

Infringement of regulations concerning marking of oversized cargo:

- in daytime: warning or fine 10 LVL to the driver;
- in darkness or limited visibility conditions: fine 20 LVL to the driver.

Transport of goods without respective permit and exceeding total laden weight up to 2t or axle-load up to 0,5t:

- fine to the driver 20 50 LVL;
- fine to the carrier or sender, private individual, 50 75 LVL;
- fine to the carrier or sender, legal entity, 75 150 LVL.

Transport of goods without respective permit and exceeding total laden weight by 2t and up to 4t or axle-load by 0,5t and up to 1t:

- fine to the driver 100 150 LVL;
- fine to the carrier or sender, private individual, 150 300 LVL;
- fine to the carrier or sender, legal entity, 1500 3000 LVL.

Transport of goods without respective permit and exceeding total laden weight by 4t and up to 6t or axle-load by 1t and up to 1,5t:

- fine to the driver 150 200 LVL;
- fine to the carrier or sender, private individual, 300 400 LVL;
- fine to the carrier or sender, legal entity, 3000 5000 LVL.

Transport of goods without respective permit and exceeding total laden weight by 6t and more or axle-load by 1,5t and more:

- fine to the driver 200 400 LVL;
- fine to the carrier or sender, private individual, 400 500 LVL;
- fine to the carrier or sender, legal entity, 5000 10000 LVL.

Transport of goods without respective permit and exceeding dimensions:

- fine to the driver 50 75 LVL;
- fine to the carrier or sender, private individual, 75 150 LVL;
- fine to the carrier or sender, legal entity, 150 300 LVL.

Illegal transport of dangerous goods:

- fine to the driver 50 200 LVL;
- fine to the carrier or sender, private individual, 250 500 LVL;
- fine to the carrier or sender, legal entity, 1000 5000 LVL.

For driving a vehicle when leakage of dangerous goods from nonhermetic tank or package is discovered: fine to the driver 50 - 200 LVL.

For transport of dangerous goods when driver does not have all respective documentation; fine to the driver 50 - 200 LVL.

For not supplying the driver with documentation necessary for transport of dangerous goods:

- fine to the carrier or sender, private individual, 50 150 LVL;
- fine to the carrier or sender, legal entity, 200 1000 LVL.

For transport of dangerous goods when requirements concerning equipment and marking of the vehicle are not complied with: fine to the driver 25 - 100 LVL.

For transport of dangerous goods when filling of the tank does not meet respective requirements:

- fine to the driver 100 200 LVL;
- fine to the carrier or sender, private individual, 150 250 LVL;
- fine to the carrier or sender, legal entity, 1000 5000 LVL.

For incompliance with the requirements concerning packing or labeling of dangerous goods:

- fine to the sender, private individual, 100 - 250 LVL;

- fine to the sender, legal entity, 1000 - 5000 LVL.

For carrying out transport operation without licence card, special permit and patent, or necessary registration certificate, or for the same infringement violating regulations of use of the said documents, as well as for refusal to show the said documents: fine to the driver 10 - 25 LVL.

For carrying out international transport operation when driver can not show international road carriage permit or violates provisions of Agreements concerning international transport of goods by road: fine to the driver 50 - 100 LVL.

149.33. Non-compliance with regulations concerning appointing of safety advisors in commercial entities, bodies and organizations involved in transport or dangerous goods by road, as well as in loading and unloading of dangerous goods

Fine to the legal entity 250 - 3000 LVL.

149.36. Non-compliance with regulations concerning transport on own account

For transport of passengers or goods on own account not having Certificate of own account transport, or refusal to show it: fine to the driver 2 LVL.

For transport of passengers or goods on own account violating conditions of its use:

- fine to the driver 10 25 LVL;
- fine to the carrier 100 200 LVL.

For transport of passengers or goods on own account without issued respective Certificate: fine to the carrier 100 - 200 LVL.

For the same infringement committed repeatedly within a year after administrative fine: fine to the carrier 250 - 500 LVL.
